
Snacks for the September meeting will be provided by Jerry Waechter, Judy Callaway and Charlie Cummings.

**Throwing a Stiff-Arm** I AM STANDING next to my green 1929 Model A Ford in this 1948 photograph (above), taken on North Cape Road in Hales Corners, Wisconsin, in front of my parents' newly built house.

I didn't like putting my arm out the window to signal left or right turns when the weather was cold, especially since the window was hard to get up and down.

So my brother, Bob Werner, cut an arm and hand out of plywood,

mounted it on the driver's side of the Ford and painted the hand light brown and the arm and fingernails red.

Bob then drilled a hole through the top of the door, tied a string to the top of the arm and snaked the string through the hole to the inside of the car. All I had to do was pull the string on the arm to show a left or right turn, moving the arm straight out or down.


